20 The California Integrated Waste Management Board brings this action to collect an
21 administrative civil penalty, which has been assessed against Defendants Wayne Earl Hambright
22 and Tami Hambright. Plaintiff California Integrated Waste Management Board is an agency of
23 the State of California, which is empowered to enforce state laws regulating solid waste disposal,
24 including the disposal and storage of waste tires.

1 Defendants Wayne Earl Hambright and Tami Hambright are the sole owners of the
2 property located at 22560 Gyle Road, Gerber, California.

3 On this property, Defendants operated a waste tire facility without a permit, accumulating
4 approximately 1000 waste tires, and committing violations of state law with regard to fire
5 prevention and vector controls.

6 Pursuant to its statutory authority under Public Resources Code Sections 42800-42859,
7 Plaintiff issued a Clean Up and Abatement Order, requiring Defendants to clean up the waste
8 tires on the property.


9 After Defendant failed to comply with the Order, an Administrative Complaint was
10 issued.

11 After execution of a stipulated agreement, Plaintiff, pursuant to its statutory authority
12 under Public Resources Code Sections 42850-42853 and through the Decision of an
13 Administrative Law Judge incorporating the terms of the Stipulation, ordered Defendants to
14 remove all the tires from the property by August 23, 2002. A certified copy of the Administrative
15 Law Judge's Decision is attached as Exhibit A.

16 Defendants have failed to comply with the Administrative Decision.

17 WHEREFORE, Plaintiff prays for Judgment in the amount of \$5500.00 with interest
18 thereon at the rate of ten percent (10%) per annum from the date of the entry of this judgment
19 until paid, pursuant to the terms of the Administrative Decision.
