Introduction

As a property owner, tenant or person has requested notice. Please be advised that the Alameda County Solid Waste Local Enforcement Agency (LEA) will be holding an informational public hearing in compliance with AB 1497 regarding a new full Solid Waste Facility Permit (SWFP) for the Livermore Sanitation Recyclable Material Transload Facility (LSRMTF). The LEA is certified by the Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste facilities within the Alameda County.

Description of project and LEA's preliminary determination

The Project Applicant, Livermore Sanitation, Inc. (LSI), currently operates a solid waste transfer and recycling facility on a 1.02 acre parcel (APN 099B-5752-17 and APN 099B-5752-18 for the trucks yard) at 7000 National Drive in the City of Livermore. The owner of the land and the facility is Livermore Sanitation, Inc. (LSI).

LSI is applying for a new full SWFP. This new permit will address the significant changes that the existing permit SWFP# 01-AA-0301 does not include. The following operational changes are being proposed as part of this process:

- Propose expansion of materials received to 385 Tons Per Day (TPD).
- Propose peak traffic volume to 104 Vehicles Per Day (VPD).
- Update the Transfer/Processing Report to include current environmental permits.

Purpose of the Meeting

This meeting is for interested parties to learn more about the proposed new permit and to provide comments to the LEA regarding the proposed action. As required by State statute, the decision to approve or deny the proposed new permit will be made by the LEA and will be submitted to the CalRecycle for concurrence at a public meeting. If you wish to be notified of the CalRecycle meeting, please notify the LEA in writing no later than July 18, 2012.
